

Log in to your MALTA account and click the edit button next to "Member Join Date (Informal Date)." We added this feature to MALTA because many members requested it.

When National Headquarters migrated member data from our previous system to our current MALTA membership system, members' join dates carried over to the new system, even if a member had joined prior to that date.

Only members may update their informal join date. This is helpful for Auxiliary Presidents, Secretaries and Treasurers who plan to organize a membership recognition event. They can run a report in MALTA to get self-reported join dates.

**GLEN ADAMS II** 

When the story of Dallas Glen Adams II, VFW Post 1802, Zumbro Falls, Minnesota, was submitted as a potential "My Veteran" subject, it was not sent in by his family, which is most often the case. Instead, it was submitted by the leadership of his Auxiliary family; his "gals." Adams' dedication to his country, his community and his VFW Post was acknowledged by all who knew him.

Adams was a member of the "greatest generation" and a World War II veteran. He was born and raised in the small town of Zumbro Falls. He was drafted into the Army in 1944 at the age of 21. Following basic training, which included hand-to-hand combat training, he deployed for Okinawa, Japan. As a member of the motor pool, he would often work 24 hours per day, acting as a guard at night.

Among the many battles in which he participated, there are a few incidents which remained at the forefront of his memories. One such battle took place in the close confines of a cave where he narrowly escaped after having his teeth knocked out. Another involved an attack that took place while he was the driver of a vehicle that was splayed with rounds of fire. One of his passengers was hit and seriously injured. The soldier lay wounded, blood dripping on Dallas as he pushed on, getting his passenger to safety.

One of his most vivid and disturbing memories took place on the beaches of Iwo Jima. The fierce and bloody five-week battle is often depicted in movies about World War II; experiencing the scene made a lasting impression on Adams. He would describe the amphibious landing, noting that thousands of U.S. troops were killed before ever reaching the shore; some flotillas were destroyed before troops disembarked and thousands more died in the surf or on the beach, so many that the sea turned red with blood. Adams' unit pressed on into the jungle, tossing hand

grenades into bunkers, silently walking along the beach and clearing the area of Japanese soldiers.

During the war, Adams transformed from a lanky 150 pounds, to a bulked up 214 pounds on his 6'7" frame. He was recommended for a career position in the Army, but declined and returned home where he was haunted by the sights and sounds of the war. After a period of adjustment, he became a farmer, an avid conservationist and enjoyed many hobbies. He wed late in life, at age 69, and spent 15 happy years married to the love of his life, Diana.

As a member of Post 1802, Adams donated generously to both the Post and Auxiliary. In September of 2010, the Post flooded to the point where the water was almost to the roof line; everything inside had to be replaced. Adams stepped up and provided significant financial support to return the Post to its original state.

Adams celebrated his 99th birthday in November 2022.

Sadly, he passed away January 5, 2023. However, he lives on in the memories of his comrades at Post 1802 and its Auxiliary, and in the hearts and minds of the residents of the small town of Zumbro Falls.

## GETTING UN-DIGITAL: PRINT ON DEMAND

Based on feedback from members, National Headquarters explored a service that would allow members and Auxiliaries to order printed editions of *VFW Auxiliary Magazine*.

This is called print on demand. If we are able to provide this, members and/or Auxiliaries would be able to order one or multiple copies of magazines that would be printed to look like they did pre-digital, and have these mailed directly to them.

#### WHAT HQ WOULD FUND:

Setup fee and a per-issue cost to prepare the magazine file.

#### **COST TO THE MEMBER:**

We hope to keep the cost at less than \$5 per issue, including postage.

#### **HOW IT WOULD WORK:**

Members or Auxiliaries would enter their order via a link on our website, including quantity, mailing address and payment information.



### **ADVANTAGES:**


Members can start getting paper editions again and in time, may even order past issues (beginning with the first print on demand issue). It would look and feel like the "old" printed magazine. Members and Auxiliaries could order one copy or multiple to share. Members would not use their own printers or ink.

### **INFORMATION TO NOTE:**

To keep cost as low as possible, orders — from everyone — would be batched. For example, if we batched at 100, all individual orders would mail to each unique address once a total of 100 were ordered from across the nation: Jane Doe from Nebraska orders two magazines, Joe Smith orders 10 for his Auxiliary in New York and so on. The batch could be reached within a few hours or days. We would need to establish an ordering deadline for each issue to ensure timely delivery.

Because it is a per-request system, unfortunately we cannot offer subscriptions.

We will keep you posted on whether we can make this available to members and if so, when. Should we be able to offer print on demand, we will need help getting the word out to members who will be most likely to use this service – those who do not have internet or computer access. AC

On the docks, sea lions, snuggled in small groups, luxuriated in the sun just feet away from the tender.
Cabo, also known as the jewel of the Baja
Peninsula, is famous for its

world-class sports fishing and

high-end resorts. It's La Calle Primera is known for souveniers. By journeying just one block away to Ventana al Mar, Window to the Sea, visitors can experience a boardwalk/seawall avenue with an enormous Mexican flag, though on the morning of our arrival, the flag was not flying.

Looking out from the ship, not a small vessel at a length of nearly 1,100 feet and capacity of nearly 6,000 guests and crew, the ocean winked under the sun and appeared to gently swell and dip. But the Bliss is a big ship traversing a huge ocean, and inside the theater where the National District Council Meeting took place, presenting on stage was a balancing act, literally. Among them were Americanism: Department of Wyoming's Legislative and Americanism Charimen teamed up to support Gold Star Mother's and Family's Day and showcased their work with #AuxSwap; Hospital: In New Hampshire, members donated pumpkins to and decorated with veterans at a VA hospital for Halloween; Legislative: In Missouri, a member had T-shirts designed the VFW Action Corps Weekly QR code printed on a sleeve; Scholarships: Members in Arizona printed scholarships information on fake \$1 million bills to give to students at a school fair; Veterans & Family Support: Also in Missouri, nine Auxiliaries sponsored three suicide awareness billboards along major highways that promote the Veterans Crisis Line/988.

Attendees also listened as both National Guard candidates, Laurie Dale of Minnesota and Sandra Uzell of Ohio, addressed the membership during the Conference. See page 13 to learn more about them.

Congratulations went out to the Southern Conference, winner of the Conference versus Conference for having the highest percentage of current membership as of December 31, 2022.

As of late March when this story was written, the VFW Auxiliary was on track to achieve more than 100% in current membership, which means we are growing! It also means we're working toward achieving our goals and furthering our mission. A personal mission this Program Year for National Membership Ambassador Jason Estell is to reach 500,000 members. Let's see if we can get there by National Convention!

Resolutions, including consideration of a dues increase, were presented by Bylaws Chairman and Past National President Sandi Onstwedder. Find those, along with any other Resolutions received from Departments, posted in MALTA Member Resources under Miscellaneous.

Returning to the home port of Los Angeles was bittersweet, saying goodbye for now to friends new and old, but looking ahead to wonderful National Convention in Phoenix where we'll meet, work and plan again. The final evening of Conference, members gathered for a reception in the Observation Lounge that has a fantastic panoramic view of the water. Reape and Borland took the mic to encourage and thank members, reflect on a successful halfway milestone this Program Year and, of course, engage in a little more friendly competition over Reape and Borland's joint project: Who in our class of 2022-2023 will raise the most money for a named Voice of Democracy scholarship – the Auxiliary or VFW?



## CAMP LEJEUNE JUSTICE ACT LITIGATION

### WHAT MEMBERS NEED TO KNOW

Are you a family member of a veteran who was stationed at Camp Lejeune between 1959 and 1987? These veterans and their families may seek damages as part of the Camp Lejeune Justice Act (CLJA) that was incorporated into

the PACT Act. We urge Auxiliary members and their veterans to contact a local <u>VFW-Accredited Service Officer</u> to begin the process of evaluating legal action.

### BEWARE OF SCAMS AND PREDATORY LAW FIRMS

If you've met with a VFW-Accredited Service Officer and determined pursuing a Camp Lejeune lawsuit is right for you, the VFW encourages you connect with a VFW-entrusted law firm. The VFW has coordinated with both Bergmann & Moore (B&M) LLC and Baird Mandalas Brockstedt Federico & Cardea LLC (BMBFC) as two options to consider in assisting with these claims.

Veterans and their family members suffering from the effect of toxic exposure at Camp Lejeune need appropriate legal representation. Hardly a day goes by that we don't see commercials and junk emails from predatory law firms that offer false promises. It's important that members and veterans connect with legal experts who know how to navigate their claims and have their best interests in mind, which is why the VFW has collaborated with two such law firms that have a long history of honorably serving veterans.

#### THEY HAVE AGREED TO:

- 1. Cap attorney fees at a reasonable rate,
- 2. No upfront costs,
- 3. Work with the VFW to ensure veterans explore their earned VA benefits,
- 4. Counsel claimants on the impact of the offset included in the Camp Lejeune Justice Act before accepting an award,
- 5. Encourage VFW membership to eligible veterans, and
- 6. Provide resources to support the VFW Service Officer Program.

Since 2014, Bergmann & Moore has successfully represented more than 3,000 VFW members in federal court and joins the VFW in attempting to ensure its members understand what is at stake and whether to join the Camp Lejeune Justice Act litigation. #### TWO-YEAR DEADLINE

The deadline for filing an administrative action with the United States Department of the Navy is on or before August 9, 2024. The CLJA provision under the PACT Act expires two years after enactment.

### **FAQS**

### HERE ARE SOME FREQUENTLY ASKED QUESTIONS ABOUT CLJA PREPARED BY BERGMANN & MOORE:

- **Q:** If I file a CLJA claim, will this impact my VA benefits or health care I already receive?
- **A:** No. VA has confirmed that your VA compensation benefits or health care services will not be impacted if you file a CLJA claim. If you receive a one-time award in the CLJA lawsuit, your VA benefits will not be reduced, and your eligibility for other VA benefits or services will not be affected.
- Q: Will VA reduce my benefits if I file a VA disability claim after I receive an award from my CLJA lawsuit?
- **A:** No. VA has confirmed that any award you receive under the CLJA will not influence VA's decision to provide you benefits or health care based upon your exposure or the amount of compensation you receive from VA.
- Q: Is it advisable to file <u>both</u> a VA PACT Act claim related to Camp Lejeune water exposure <u>and</u> a CLJA tort claim?
- **A:** Generally, yes. As noted above, VA has confirmed that a CLJA award will not affect VA benefits and care. A CLJA claim is simply a separate remedy for individuals who suffered from toxic water exposure at Camp Lejeune. An award under the CLJA will be a one-time monetary benefit which Congress has recognized as a remedy for individuals who fit the definition of coverage.

### **Q:** Do I need to have any of the presumed Camp Lejeune illnesses to file a CLJA claim?

**A:** No. VA and Department of Defense (DOD) have recognized a limited number of presumptive conditions as being linked to the toxic water at Camp Lejeune; however, there are multiple other conditions and diseases that can still be linked to the toxins that were released into the ground water at Camp Lejeune. If you suffer from a condition that you think may be related to your exposure, you should file a CLJA claim. Your attorney will examine the evidence and advise (after consulting with a medical expert) whether your condition may be related to toxic ground water exposure.

### Q: I have already signed a fee agreement with another law firm to represent me in my CLJA claim. Can I change firms?

A: Yes. Just because you have already signed with another law firm does not mean you are stuck with that firm, especially if you feel the attorney fees and costs are too expensive. To change firms you will need to communicate with the firm in writing – via mail/email or text is fine. Your letter/note simply needs to say: "I would like to discharge you as my attorney in my CLJA claim. Please return any information I sent you." You do not need to wait for their reply. When you sign up with another firm you should provide the new firm with a copy of the letter/note you sent the initial firm. They will let you know if any additional information is needed.

### Q: The law firm I signed up with sent me a check related to my CLJA claim that I already cashed. May I still switch law firms and how will this affect my claim?

**A:** This is what is called an "Advance." In all jurisdictions an advance in contemplation of litigation is generally illegal. The American Bar Association's (ABA) Model Rules of Professional Conduct (MPRC) prohibits this practice. Specifically, Rule 1.8(e) states that:

A lawyer shall not provide financial assistance to a client in connection with pending or contemplated litigation, except that:

(1) a lawyer may advance court costs and expenses of litigation, the repayment of which may be contingent on the outcome of the matter; and

(2) a lawyer representing an indigent client may pay court costs and expenses of litigation on behalf of the client.

North Carolina's Revised Rules of Professional Conduct Rule 1.8, mirrors the ABA's MPRC Rule 1.8, as quoted above. See N.C. Rev. R. Prof. Conduct § 1.8(e). This means that unless CLJA settlement funds are paid to the lawyer, the lawyer cannot advance settlement proceeds to a client.

### Q: Related to attorney fees and expenses, what should I generally be aware of?

**A:** CLJA claimants should be aware of the fees and costs they may be paying to a law firm related to their CLJA claim. If a firm is not willing to immediately explain/ share their fees and costs related to representation, you should not talk to them. It is important to confirm both the fees and the costs as these are distinct. Generally, costs are not known until the end of the litigation so these can always change. We suggest that you look for a firm that caps fees and costs.

A question Auxiliary members may ask is:

### Q: Can a family member of a veteran who passes away pursue CLJA litigation?

**A:** Yes. Any individual, including a veteran, spouse or family member who was stationed at Camp Lejeune or who was otherwise exposed (including in utero exposure) for 30 or more days during the statutory period may be eligible to pursue a claim under the Act. The spouse or legal representative of a veteran who passed away and who was stationed at Camp Lejeune may pursue a claim under the Act.

Because the CLJA litigation is in the early stages, many unknowns exist as processes continue to be developed to handle the many claims being filed. As such, it is important to stay connected. VFW is dedicated to keeping its members informed as the litigation progresses.

for wounded veterans since World War I, volunteering in federal, state and private hospitals. The top three 2022-2023 Auxiliary VAVS Volunteers of the Year are: First place, Cynthia Davis, Department of Maryland; second place, Glenda Hunt, Department of Texas, and third place, Brenda Blair, Department of Maine.

VAVS National Advisory Council (NAC) comprises key VA staff members and leaders from the veteran service organizations who provide volunteers. In addition to the many support and coordination responsibilities of the NAC, they also accept nominations for their Volunteer of the Year designation.

As the first-place winner for the Auxiliary, Davis, who has served as a VAVS volunteer for more than nine years, was submitted to the National Advisory Committee for the national phase of judging. For her dedication in her position as a dispatcher in the escort service at Loch Raven VA Medical Center, for which she serves three to five days a week, Davis has been selected as the NAC Volunteer of the Year. Additionally, she volunteers as a phone buddy to veterans of Loch Raven VA Medical Center. Davis was also selected as the Baltimore VA Medical Center Volunteer of the Year. She was honored for her volunteer work and presented with an award at the NAC Conference held in Denver, Colorado.
